

KS2 pupils e-safety agreement

For my own personal safety - everywhere!

- I will ask permission from a member of staff before using the Internet at school.
- I am aware of "stranger danger" when online and will not meet online friends.
- I will tell an adult about anything online which makes me feel uncomfortable.
- I will not try to bypass the system to reach websites the school has blocked.
- I understand that the school may check my files and may monitor the web pages I visit.
- When in school I will only contact people with my teachers permission.



- I will be very careful when sharing pictures or video of myself or my friends and if I am in school I will always check with a teacher.
- I will not put my "personal information" online (full name, birthday, phone number, address, postcode, school etc.).

To keep the system safe

- I will only use my own login and password, which I will keep secret.
- I will not access other people's files.
- I will not play games on a school computer unless my teacher has given me permission.
- I will not install software on school computers.
- I will not use the system for gaming, gambling, shopping, or uploading videos or music.



Responsibility to others

- The messages I send will be polite and responsible.
- I will not upload images or video of other people without their permission.
- I will ask permission before printing out information or pictures.
- Where work is copyrighted (including music, videos and images) I will not either download or share with others.
- I understand that the school may take action against me if I am involved in incidents of inappropriate behaviour wherever their location. If the activities are illegal this may be reported to the police.



Personal Devices

- The school cannot accept responsibility for loss or damage to personal devices.
- It is not permitted for pupils to use mobile phones or other electronic devices (tablets, games consoles, mp3 players, ipods etc.) during the school day.
- If phones or other electronic devices are brought into school (e.g. for emergency purposes) they should be handed in to the class teacher at registration.

Permission to take and use photographs of children

Sometimes we take photographs of the children. These are mainly used for educational reasons but occasionally we may use these images in our publicity or the school's prospectus or in other printed publications as well as on our website and class blogs. We may also make video or webcam recordings for school-to-school conferences, monitoring or other educational use.

From time to time, our establishment / school may be visited by the media who will take photographs or film footage of a visiting dignitary or other high profile event. Pupils will often appear in these images, which may appear in local or national newspapers, websites or on televised news programmes.

To comply with the Data Protection Act 1998, we need your permission before we can photograph or make any recordings of your child. Please answer questions 1 to 4 below, then sign and date the form where shown.

Conditions of school use

1. This form is valid for five years from the date you sign it, or for the period of time your child attends this school or setting. The consent will automatically expire after this time. It is your responsibility to let us know if you want to withdraw or change your agreement at any time.
2. We, the school, setting or service, will not use the personal details or full names (which means first name **and** surname) of any child in a photographic image on video, on our website, in our school prospectus or in any of our other printed publications.
3. We will not include personal e-mail or postal addresses, or telephone or fax numbers on video, on our website, in our school prospectus or in other printed publications.
4. If we use photographs of individual pupils, we will not use the name of that child in the accompanying text or photo caption, unless we have your agreement.
5. If we name a pupil in the text, we will not use a photograph of that child to accompany the article.
6. We may include pictures of pupils and teachers that have been drawn by the pupils.
7. We may use group or class photographs or footage with very general labels, such as "a science lesson" or "making Christmas decorations".
8. We will only use images of pupils who are suitably dressed, to reduce the risk of such images being used inappropriately.
9. **As the child's parents/guardian, we agree that if we take photographs or video recordings of our child/ren which include other pupils, we will use these for personal and family use only.** I/we understand that where consent has not been obtained from the other parents for any other use, we would be in breach of the Data Protection Act 1998 if we used our recordings for any wider purpose.
